Centralized services in special areas -not in our warehouse- are for following goods: VAL / AVI / RRY / Explosives /
3. Dangerous goods invoicing info
 - a. Dangerous goods services for acceptable export shipments are billed to the exporting airline
 - b. Dangerous goods services for non-acceptable export shipments are billed to the delivering Agent
 - c. Dangerous goods services for acceptable Import shipments for destination FRA are billed to the consignee
 - d. Dangerous goods services for non-acceptable Import shipments and for Import transit shipments-not FRA- are billed to importing airline
